

UOB YOLO CREDIT CARD CONTIKI TOURS TACTICAL PROMOTION TERMS & CONDITIONS UOB YOLO CREDIT CARD

United Overseas Bank (Malaysia) Bhd (271809-K) ("UOBM") is organising a "**UOB YOLO CREDIT CONTIKI TOURS TACTICAL**" Promotion ("Promotion") from **2 January 2019 to 28 February 2019** (both dates inclusive) or such other dates as may be determined by UOBM from time to time ("Promotion Period").

Promotion Eligibility

1. This Promotion is open to all eligible principal and supplementary UOBM YOLO Credit Cardmembers ("Eligible Cardmembers") who hold a UOB YOLO Credit Card ("Card") issued in Malaysia and:
 - (a) whose accounts with UOBM are current, subsisting and not in default in any manner as may be determined by UOBM at its sole and absolute discretion; and
 - (b) who are not in breach of the UOBM Visa/MasterCard Cardmember Agreement ("Cardmember Agreement").
2. Customers who only hold a corporate card or purchasing and private label card are not eligible to participate in the Promotion.

Promotion Mechanics

3. Under the Promotion, the Eligible Cardmembers will be entitled to the travel packages available at <https://www.holidaytours.com.my/uob-yolo/> (collectively known as "Travel Website").
4. All payments for the travel packages must be made with the Card to be entitled for the Promotion.
5. The Promotion is not valid to be used with other offers, promotions, discounts, vouchers, coupons, privilege cards or for purchase of gift vouchers, unless otherwise stated.
6. To be entitled to the travel privileges, prior booking is to be made by contacting our **UOB Travel Planner at 03-6286 6229**. Bookings are strictly subject to availability and confirmation must be made within the booking period stated in the Travel Website.
7. Upon confirmation of the booking, the Eligible Cardmember's account will be charged with the full price of the travel packages. In the event of cancellation or amendments to the bookings made (e.g. the dates of stay, flight, the travel destination, etc.), cancellation or amendment fees will be charge by Holiday Tours & Travel Sdn Bhd ("Participating Merchant") at the rate determined by them
8. The price quoted for the travel packages in relation to the Promotions is on per person and twin sharing basis.
9. The travel packages are inclusive of accommodation, meals and sightseeing as stated in the itineraries but exclusive of tour tips, airfares, airport tax, fuel surcharge, visa fees and insurance fees.

UOBM shall not be responsible for any failure or delay in transmission of sales transactions by Visa International Incorporated, merchant establishments, postal or telecommunication authorities or any party in which may result in the Eligible Cardmembers failing to be entitled for this Promotion.
17. UOBM is not affiliated with the Participating Merchant and makes no representation or warranty with respect to the quality of their products or services for any purpose.
18. UOBM shall not be liable for any misrepresentation or misinterpretation of facts by any unauthorized third party in respect of this Promotion which is published in any mass media, marketing or advertising materials.

UOBM reserves the right to add, delete, suspend and/or vary these terms and conditions, from time to time, wholly or in part, at its absolute discretion, by providing twenty one (21) calendar days prior notice to the Eligible Cardmembers through posting on UOBM's website, displaying a notice at any of UOBM's branches, a statement insert in the Statement of Account and/or any other manner as may be determined by UOBM from time to time.
24. These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Cardmembers agree to submit to the non-exclusive jurisdiction of the courts of Malaysia.
