TERMS AND CONDITIONS
UOBM CREDIT CARDS

Eligibility

1. United Overseas Bank (Malaysia) Bhd (271809-K) ("UOBM") Starbuy Programme ("Promotion") is open to all eligible UOBM principal and supplementary Credit Cardmembers ("Cardmembers") whose account(s) are current, valid, subsisting and in good credit standing as may be determined by UOBM at its sole and absolute discretion.
2. This Promotion is only applicable to UOBM Credit Card ("Card")
3. The following shall not be eligible for the Promotion:-
 - a. Cardmembers whose account(s) held with UOBM are terminated, suspended or cancelled within the Promotion Period;
 - b. All UOBM Debit, Private Label, Business, Purchasing and Corporate Cardmembers;
 - c. Cardmembers whose account(s) held with UOBM are delinquent or unsatisfactorily conducted as determined by UOBM at its sole and absolute discretion; and
