

**UOBM SHOPEE – 9.9 PROMOTION**  
**TERMS & CONDITIONS**  
**UOBM CREDIT AND/OR DEBIT CARD**

**Eligibility**

United Overseas Bank (Malaysia) Bhd (271809-K) (“UOBM”) “Shopee – 9.9 Promotion” (“Promotion”) is open to all eligible principal and supplementary UOBM Credit and/or Debit Cardmembers (“Cardmembers”) whose account(s) are current, valid, subsisting and in good credit standing as may be determined by UOBM at its sole and absolute discretion.

- Not applicable with baby formulas, baby foods & supplements, diapers & potties, tickets & vouchers, mobile top-ups, SIM cards and bill payments.
