

**UOBM KLOOK IN SINGAPORE PROMOTION  
TERMS & CONDITIONS  
UOBM CREDIT AND/OR DEBIT CARD ("CARD")**

United Overseas Bank (Malaysia) Bhd (271809-K) ("UOBM") and Klook ("Merchant") is organising a "UOBM KLOOK in Singapore Promotion" ("Promotion") from **1 March 2018 until 31 December 2018** (both dates inclusive) unless otherwise notified ("Promotion Period").
